### **ANNOUNCEMENTS:**

City News: Mayor Wilson said that the Northmoor website is up and running, thanks to Scott Murdock. She said we are now adding a new feature called the "Court Money Program." The State will soon require the City to have a website that can take payments. Using the "Court Money Program" we can collect court fines and water payments online. It will not cost the city any money. The cost of the convenience will go to the consumer.

The Laundromat was burglarized along with more laundromats north of the river. There are photos of the burglar circulating. He continued by stating that the department had dealt with the limousine service problems, but now the limousine service is offering a service on "Group-On", which he had seen personally. The business was in the sons name and is in the mothers name now. They are not running a legitimate operation.

- Reading (2) and motion to approve an ordinance adopting Costs for Installation of Water Meters -Mayor Wilson briefly explained the problems with installing new water service on old transite pipes. Stanley Anderson, JC Riddle, Julie Rowden and Mayor Wilson have been conversing and comparing notes. The ordinance and attachments will be revamped for approval of the Board at our February meeting. ### **NEW BUSINESS:**

- Discussion of a new Business License application for Charles Richey/Chuck's Thrift Store Julie noted that she had received the application and emergency contact forms with a check. The question arose as to if they are still a non-profit organization, due to the name change. Alderman Harris stated they are still tax exempt. He said that Chuck is ill at this time so could not attend the meeting. He continued by stating that eventually someone else will run the store. The City will require the tax exempt letter before they can obtain a new license. Mayor Wilson said that the store has been divided into the 2 areas, 2/3 – 1/3 – the 1/3 being up for lease. She commended Alderman Harris on the new doors, saying they are very nice.
- 2. Approval of a new Business License application for Virgil White/Adelitas Mexican Restaurant. Virgil said that, for now, they would be continuing the same hours for the first month and then 8:00 a.m. to 8:00 p.m. (possibly 9:00 p.m.). The business owner change won't be noticed. There will be no closing of the business. February 1<sup>st</sup> will be when Virgil takes over. There will be no name change just an addition of LLC. In conjunction, he would like to sell beer. Flavored margaritas are considered malt liquor according to the Mayor. Mayor Wilson said that we do have a liquor license available since The Mir Hookah Lounge has closed. Alderman Medill asked what the impact is on the City, beer/wine license vs. full bar license. Mayor Wilson said revenue would not be as large as a full bar. Virgil said Michael Gunn wants to sell The Mir Hookah Lounge as a bar and would need the full license. Alderman Medill suggested giving the full bar liquor license to Virgil. Alderman Harris suggested amending our ordinance for a beer and wine. Alderman Pate made a motion to approve the business license application and full liquor license for Adelitas Mexican Restaurant, Alderman Medill seconded the motion. All in Favor: 4 Opposed: 1 Motion carried. Alderman Harris feels strongly that the Board will need to allow 1 more full liquor license for when Michael Gunn sells the property where The Mir Hookah Lounge was. All present seemed to be in agreement.

Mayor Wilson mentioned the need to purchase signs for truck weight limits of 30,000 pounds. Mayor asked Joe to let us know how many signs we need. Chief Clark will order the signs.
