POLICE REPORT: Chief Lorenson

Calls for Service-36 Traffic-46 Citations-40 Warnings-14

- 1. Chief Lorenson said that the month had been busy with calls for service. The department received a few requests for mutual aid from Riverside PD. They are becoming more familiar with our officers. There have been some reports of suspicious parties in our area and our officers check these reports promptly. They are also concentrating on identifying people on foot in the City. There have been no reports of stolen catalytic converters this month. The construction on Vivion has cut down on traffic through the city temporarily. Repairs have been made on the Crown Vic.
- 2. ITI is now operational. The officers are going through a learning curve. It is a good program but there are a few bugs to work out. Right now they are only pulling reports. The printer should be in the car in about a week.
- 3. Sgt. Williams and Lieutenant Randolph have been assigned with reporting the state NIBRS. There is a lot of data entry and this is good since Lieutenant Randolph is on light duty and Worker's Compensation. Chief Lorenson has also been trained and could do NIBRS as well.
- 4. Alderman Butner has been appointed as Police Liaison. Deputy Chief Schuettenberg remains the liaison between the Court and Police. It works well.

- 5. Riverside Police Department requested to go paperless on city warrants. Chief Lorenson and Elizabeth are for the change. Mark Ferguson runs both Riverside and Northmoor courts. This will allow for less contact. Our courts continue to gain more authority for warrants and arrests since COVID is being controlled.
- 6. Chief Lorenson is working with MVP Pizza to set up a date for "Pizza with the Police."
- 7. Chief Lorenson announced that he is hiring Dr. C. Lan Fotopoulos, M.D. as a Volunteer Police Officer. Chief Lorenson touched on just a few of his accreditations. Dr. Fotopoulos is a surgeon for the Kansas City Royals and is also affiliated with the KC Explorers tennis team and the Boxing and Mixed Martial Arts Physician for the State of Missouri. He doesn't want paid. He wants to teach fellow officers and citizens CPR and other skills. He will be present at City events as well.

1. Mayor Wilson stated that she has received a Citizen complaint regarding Northmoor Ave. Deputy Chief Schuettenberg said that he has already written 3 to 5 letters. He also sent out 9 letters last Thursday and 7 have already complied and 1 was written a citation. The Baker property is being cleaned up. Craig has taken care of the millings and the place is looking better. Mayor Wilson would like a copy of the letter to Annie Duff from Scott Sullivan when it has been prepared.
