9. Review of Invoices for the time of September 16th through October 15th and October 16th through November 15th from the Office of the Northmoor City Attorneys

NEW BUSINESS:

1. Staff – Purchase turkeys, Police Department – Gift Cards
The Board decided not to give Christmas bonuses or gifts to the staff this year. Scott Sullivan recommended no Gift Cards.

OLD BUSINESS:

- Scott Sullivan Discussion and vote on Quit Claim Deed for Fagan Property
 There are no additional Liens on the Fagan Property. Scott provided two options to get the Title in the City's Name.
 - * Quit Claim Deed would have to contact each and everyone in the bloodline and even then, that's not a Warranty Deed
 - * Contact Foreclosure Attorney for handling

Mayor Wilson asked several Alderman what they thought. Alderman Medill, Alderman Murdock and Alderman Harris agreed the best option was to seek a Foreclosure Attorney.

- 2. Scott Sullivan reviewed the status of the claim for the water main break made by Ervin Cable Construction (Bright Source Communication), on November 12, 2020. Scott has contacted and has been trying to work with Dixie Price and still hasn't received a response or payment. Scott Sullivan suggests if the matter isn't resolved by January 2023, the City should sue the company.
- 3. Scott Sullivan Explanation of Public Safety Tax. We are not permitted to create a sales tax for Public Safety. Scott explained the classes and encouraged the Alderman to contact their State Representatives to get added to a class, so that it can be voted on.

POLICE REPORT:

1. Docket Review. Chief Williams indicated that overall crime is down. He advised that the number of tickets will be decreased because of being short Officers.

- 2. Mayor Wilson provided an update regarding resignations of Officers and made note that the city currently has 2 Officers remaining.
- 3. Mayor Wilson led the discussion and vote to appoint:
 - Leroy Williams as Interim Chief Since Andy Lorenson departed from the Police Department, Leroy has stepped up and taken responsibility in his absence, including handling of multiple bar cards, and creating a database for tracking. Alderman Butner and Alderman Murdock were adamant that, although Leroy has been doing a good job, they don't want him as the permanent Chief of Police. Alderman Butner inquired about the ad for Police Personnel and wanted to know if the salary was included. Mayor Wilson shared that there have been no applicants from the 3 ads.
 - Lucas Hill as Interim 2nd in command.
- 4. Leroy recommended that the city eliminate Allure to save \$500.00 per year. This program hasn't been used in a couple of years. The program is not needed.

5. Mayor Wilson, the Board of Alderman, and the Residents discussed pros and cons to adding graphics to the car. Chief Williams prefers the car be marked with graphics. Alderman Harris suggested even the bare minimum would be better than it is now. Alderman Murdock commented that she feels it should be up to the new Chief of Police. Alderman Pate is concerned about "hiding" the car. Alderman Butner insists on the car remaining unmarked. Residents in attendance prefer to have a marked car. Alderman Griffith commented regarding the unnecessary expense at this time. Chief Williams doesn't think this is a priority right now because going into the Winter months the Tahoe will be driven. Alderman Medill understands both sides. At the end of the conversation, Alderman Murdock and Alderman Medill noted no decision had to be made this evening.

CODES ENFORCEMENT:

1. The residents asked about who was handling codes and expressed their concerns and needing a Codes Enforcement Officer. The residents also expressed the fact they didn't appreciate the favoritism shown by previous Codes Enforcement Officer, Leroy Schuttenberg. The residents were informed that Brian Lederer will be our Codes Enforcement Officer and that he is currently completing the Police Academy.

CANIDATE PAPERWORK:

1. Candidate paperwork, form 5120 was distributed to Mayor Wilson, Alderman Harris, Alderman Medill, and Alderman Griffith for signature for the General Election, April 4, 2023. Form 5120 was collected from all Alderman Candidates except Alderman Medill who chose to wait to complete his. Alderman Butner notarized the paperwork that was collected at the meeting.
